Harrison County Child Development Center offers an educational program for children who require individualized learning materials and specially trained teachers.

Kinship Care Navigator Program was created to support caregivers by offering information, referrals, and connections to federal, local, and state programs.

Mississippi 2-1-1 keeps an accurate and comprehensive database to find health and human services to meet your needs.

Mississippi Access to Care (MAC) Centers are welcoming and accessible places where

people can obtain information and assistance in locating long-term care services or applying for benefits.

Mississippi Client Assistance Program (MS-CAP) is a state managed and federally funded program designed to advise and inform clients and client applicants in the state of Mississippi regarding services and benefits.

Mississippi Coast Community Resource Guide is a comprehensive list of resources designed to assist individuals in finding assistance for food, clothing, employment, health, housing, educating and more.

Mississippi Council on Developmental Disabilities (MSCDD) is a federally mandated body of advocates appointed by the Governor to promote a better quality of life for individuals with developmental disabilities, their families, and their communities.

Mississippi Early Childhood Inclusion Center works to meet the needs of early childhood educators, families, and young children with disabilities by providing high quality early childhood inclusion.

Mississippi Paralysis Association raises awareness, provides grants for adaptive and durable equipment, research grants, support groups, and scholarships for individuals with paralysis.

Mississippi Parent Training & Information Center provides families of children with disabilities information, resources, support and training that allows your child to meet his or her educational goals.

Mississippi Project START (Success Through Assistive Rehabilitative Technology) is the federally funded Assistive Technology Act Program for the State of Mississippi and operates under the Department of Health and Human Services' Administration of Community Living.

Mississippi Society for Disabilities provides opportunities and resources for children and adults to live healthier and more active lifestyles through sports, arts, healthy living, and inclusive play regardless of abilities.

MRC Community Based Services can help people with brain injuries live independently.

MRC Disability Determination Services
DDS determines your eligibility for Social
Security disability benefits.

South Mississippi Regional Center (SMRC) provides community services, community home programs, and residential services for individuals with intellectual or developmental disabilities.

St. Francis Ministries provides a variety of services, including supervised, shared, and supported living, supported employment, and job discovery services to adults with intellectual and developmental disabilities, so they can live and work as independently as possible.

Team Luke Hope for Minds exists to enrich the lives of children impacted by a brain injury and to give hope to their families through support, education, and resources.

T. K. Martin Center Assistive Technology specializes in assistive technologies that increase the independence and overall functional capabilities of persons with brain trauma.

The Institute for Disability Studies provides support and resources for individuals with disabilities, families and professionals at no cost. Services include inclusive art and recreation, family support and engagement, inclusive volunteer opportunities, employment training,

transition support, and an assistive technology and equipment lending library.

Traumatic Brain Injury/Spinal Cord Injury (TBI/SCI) Waiver is a home and community-based waiver that provides services to people with brain/spinal cord injury who would require the level of care found in a nursing facility without this waiver.

Vocational Rehabilitation with MDRS is committed solely to helping people with disabilities achieve independence through employment. Services may include vocational evaluation, counseling and guidance, educational assistance, job training, job placement, and assistive technology.

Financial Aid

Bridge to Independence assists qualified residents of nursing home and intermediate care facilities with intellectual and developmental disabilities explore community living options.

Feed my Sheep is dedicated to providing nourishment to people without homes, individuals who are homebound, and individuals in need in the Gulfport area.

Feeding the Gulf Coast is a hunger-relief program for individuals along the central gulf coast.

GrantWatch- Disability Grants information about available government and foundation grants.

Loaves and Fishes serves breakfast, lunch and to-go snack bags, delivers fresh meals to people who are homebound, and offers a "Community Give Away" of non-designated goods so that patrons can shop for their specifics needs.

Mississippi ABLE is a savings account for individuals with disabilities that will not

affect their public benefits, which can be used for daily transactions and/or long-term savings.

Supplemental Nutrition Assistance Program (SNAP) offers aid to eligible lowincome families and individuals to ensure these families are able to obtain a nutritious diet.

The Assisted Living Waiver is a home and community-based waiver that provides services to people 21 and older who meet specific requirements who would require the level of care found in a nursing facility without this waiver.

The Elderly and Disabled Waiver benefits individuals 21 years and older who would require nursing facility care without the assistance of this waiver.

The Independent Living Waiver is a home and community-based waiver that provides services to people 16 and older who have severe orthopedic/neurological impairments who would require the level of care found in a nursing facility without this waiver.

The Intellectual

Disabilities/Developmental Disabilities Waiver provides services to individuals who, without this waiver, would require placement in an Intermediate Care Facility for Individuals with Intellectual Disabilities.

The Lord is My Help advocates for the hungry, needy, and politically under-represented members of the Gulf Coast Community.

Traumatic Brain Injury/Spinal Cord Injury
Trust Fund Program provides direct
services to clients with brain injuries and
spinal cord injuries as well as awards subgrants to organizations throughout the state
to support programs that focus on awareness
and prevention.

U.S. Department of Labor Disability Resources The federal government website for comprehensive information about disability-related programs, services, policies, laws and regulations.

Healthcare

Bethel Free Clinic provides quality health care services, at no charge, to people without access to basic care.

Bethesda Free Clinic provide free medical and simple dental treatments, as well as lifestyle coaching care.

Children's Health Insurance Program (CHIP) State Plan provides health coverage to children in families that earn too much money to qualify for Medicaid but not enough to buy private insurance.

Early Intervention/Targeted Case
Management (EI/TCM) is a process that is
carried out by a case manager to assist a child
(0 to 3 years of age) enrolled and
participating in the Mississippi Early
Intervention Program gain access to needed
medical, social, educational and other
services.

Head Start and Early Head Start programs in Jackson County offers early intervention in education, health, nutrition and socialization.

Health and Prescription Services provides assistance with life-saving prescriptions, small medical devices, medical supplies, and medical related travel outside the coastal area, referrals, and educational wellness tools.

Healthier Mississippi Waiver covers individuals who are not eligible for Medicare.

Medicaid is a state and federal program that provides health coverage for eligible lowincome populations.

Medicare is a federal health insurance program for retirees age 65 or older and people with disabilities.

Medicare Rights Center is a national, nonprofit consumer service organization that works to ensure access to affordable health care for older adults and people with disabilities through counseling, advocacy, educational programs and public policy initiatives.

Mississippi Coordinated Access Network (MississippiCAN) is designed to help improve the health and well-being of Medicaid beneficiaries.

My Brother's Keeper has a mission to reduce health disparities throughout the United States by enhancing the health and well-being of minority and marginalized populations through leadership and collaboration with the public, and community healthcare practices.

National Health Law Program includes detailed information about federal health policy, especially Medicaid and Medicare.

State Attendant Care provides personal care services to individuals who have severe disabilities and are not eligible to receive these services through other sources.

The Early and Periodic Screening,
Diagnosis, and Treatment (EPSDT) is a
service which provides preventive and
comprehensive health services for children
from birth up to age 21 who are eligible for
Medicaid.

Volunteers in Medicine Gautier (VMG) provides free basic/general medical services to individuals who are uninsured.

Legal Advocacy

Mississippi Center for Justice provides free legal services to low-income families in the area of fair housing, foreclosure prevention, expungement, HIV/AIDS discrimination, and immigrant rights.

Mississippi Center for Legal Services is a guide to free civil legal services for lowincome persons and seniors in Mississippi.

North Mississippi Rural Legal Services (NMRLS) is a nonprofit tax-exempt organization providing free civil representation to low-income persons in the northern 39 counties of Mississippi.

Self Advocates Becoming Empowered (SABE) is the United States' national selfadvocacy organization that works to ensure that people with disabilities are treated as equals and are given the same decisionmaking opportunities.

Southern Disability Law Center is the Protection & Advocacy agency for Mississippi. SDLC is a non-profit law office dedicated to advancing the rights of individuals with disabilities throughout the south.

The Academy of Special Needs Planners consists of special needs planning professionals such as attorneys, financial planners and trust officers that assists in providing the highest quality service and advice to persons with special needs and their families.

Treatment and Rehabilitation

AbilityWorks is a network of community rehabilitation programs that provide vocational assessment, job training, and actual work experience for individuals with disabilities.

Methodist Rehabilitation Center has helped thousands of brain injury patients reach the highest possible level of independence.

NeuroRestorative serves people of all ages with brain, spinal cord and medically complex injuries, illnesses and other challenges.

REM Mississippi is a community-based, innovative health and human services provider, offering programs, such as day services, pre-vocational services, and home and community supports for individuals with intellectual and developmental disabilities, as well as those with complex emotional, behavioral and medical challenges.

Select Specialty Hospital provides a continuum of care to individuals with medically complex conditions.

Shepherd Center's Brain Injury Rehabilitation Program provides a full continuum of services to treat patients who have experienced a traumatic brain injury (TBI) or non-traumatic brain injury.

TASS Brain Injury Rehabilitation Center provides a tranquil, relaxing environment to support recovery from brain injury or spinal cord injury.

The Children's Rehabilitation Service (CRS) is offered by Children's of Mississippi, part of University of Mississippi Medical Center. CRS provides physical and occupational therapy evaluations and treatment for infants, children, and adolescents with physical, developmental, or chronic medical disabilities.

Transportation

Coast Transit Authority offers transportation for individuals with disabilities for small fee. If needed, attendant adult rides free. MTM Mississippi Non-Emergency
Transportation Manager provides free
transportation to medical appointments for
children with one accompanying adult.
Reservations must be made three business
days prior to appointment date and can be
made up to 30 days in advance.

Non-Profit Resources

Arc of Mississippi enhances the lives of people with intellectual and developmental disabilities and their families. They fulfill this through advocacy for community supports and services that foster social inclusion, self-determination, and equity across all aspects of society.

Art For All Mississippi Community Art Group is a gathering of adult artists with disabilities. The group creates art for sale and commissions.

Best Buddies of Mississippi is an organization dedicated to enhancing the lives of people with intellectual disabilities by providing opportunities for one-to-one friendships and integrated employments. They also arrange e-Buddies for individuals.

Brain Injury Association of Mississippi Support Groups provides a listing of various brain injury support groups throughout Mississippi.

Brandi's Hope Community Services provides an array of services for people with Intellectual/Developmental disabilities.

Brothers and Sisters Together provides support for siblings of people with disabilities in Mississippi and promotes advocacy to address issues facing them and their families.

Camp Looking Glass seeks to provide a supportive environment that promotes independence and self-determination for people with disabilities.

Casey's Circle A nonprofit dedicated to helping families of children with special needs find ways for their kids to be kids firstpatients later. This is done by providing tools, education, resources and opportunities to help improve the quality of life or medically complex children, their families and their providers, while also strengthening their circle of care.

Dream Foundation Volunteer-driven wishgranting organization that serves children ages 3-18 who have a critical or chronic illness.

Dream Street is a summer camp for children with various physical disabilities, and was founded with the mission that all children, regardless of their abilities, must be offered the chance to have fun, to make new friends, to achieve, to be accepted for who and what they are, and to learn from the challenges of group life.

Easter Seals offers a variety of services to help people with disabilities address life's challenges from child development centers to physical rehabilitation and job training for people with disabilities.

First Hand Foundation Financial Assistance.

Fund It Forward For anyone with a diagnosed disability or medical condition in need of medical devices or equipment.

Granted Wish Foundation Sports/Athlete specific wishes for people with a physical disability age 5-25.

LIFE (Living Independence For Everyone) Mississippi provides information, peer support, advocacy, skills training, community transition and other services to individuals with disabilities.

Manna Ministries provides food, clothing, free primary medical care and other necessities of life to individuals and families who lack these essentials due to low income or poverty.

Mississippi Gulf Coast Buddy Sports provides leisure and sports opportunities for individuals with special needs, including baseball, kickball, and fishing. **Modest Needs** Short term critical-need financial assistance for those who do not qualify for traditional assistance because of income level.

National AMBUCS, Inc. is creating mobility and independence for people with disabilities by therapeutic tricycles to individuals unable to operate a traditional bike, awarding academic scholarships for therapists, and performing various other forms of community service.

National MS Society Resources, support and programs for those living with multiple sclerosis.

National Organization for Vehicle Accessibility small grants to help complete accessible van purchases after other funding has been secured.

National Patient Travel HELPLINE Provides assistance and referral to the best source of charitable medical air transportation help.

Ragan's Hope helps parents of children with catastrophic injuries by providing financial, emotional and spiritual support, in the name of Christ.

Ray Tye Medical Aid Foundation Grants for in-hospital life-saving treatments and surgeries for those who do not have medical insurance.

RxAssist Provides information on financial support organizations that help with the cost of prescriptions.

Single Mothers Grants provides financial assistance for utility bills, childcare, college, medical bills, medications, rent assistance, buying a home and more.

Special Olympics Mississippi serves children and adult athletes who have intellectual disabilities to provide year-round

The Dream Program was founded to serve and enhance the quality of life for people with disabilities in Mississippi. They provide various inclusive art and sports programs for people with and without disabilities free of charge.

The Special Needs Alliance helps individuals with disabilities, their families and the professionals who serve them.

The Sunshine Foundation Grants special dreams to children, ages 3-18, who are chronically or seriously ill, physically challenged or have been abused.

United Ability is a non-profit that provides innovative services connecting people with disabilities to their communities and empowering individuals to live full and meaningful lives; particularly through building skills, education, and employment opportunities.

United HealthCare Children's Foundation - Family Grants UHCCF grants provide financial help/ assistance for families with children that have medical needs not covered or not fully covered by their commercial health insurance plan.
