Financial Aid

Child Care Assistance is available through MI Bridges for parents who cannot afford to pay for childcare services.

Emergency Relief: Home, Utilities & Burial Emergency support is designed to maintain low-income households that are normally able to make ends meet but occasionally need help when unexpected emergency situations arise.

Food Assistance Program provides temporary food assistance for eligible low-income families and individuals is available from the U.S. Department of Agriculture.

GrantWatch- Disability Grants information about available government and foundation grants.

Healthy Michigan Plan make health care plans available to individuals at a low cost.

Michigan Department of Health and Human Services – State Disability Assistance (SDA) provides cash assistance to eligible disabled adults, their caretakers, and people age 65 or older.

Michigan Low Income Home Energy Assistance Program (LIHEAP) provides benefits to low-income households who meet all State Emergency Relief (SER) eligibility requirements to help them with household heat and electric costs.

MIChild is a health insurance program for uninsured children of Michigan's working families.

The Children with Special Needs Fund provides support for children in Michigan with special health care needs not available through any other funding source. The Fund helps with the purchase of equipment and services that promote optimal health, mobility, and development, enhancing the lives of children and their families.

The Emergency Food Assistance Program distributes food quarterly to families in need.

The Family Independence Program (FIP) provides temporary cash assistance to families with children and pregnant women to help them pay for living expenses such as rent, heat, utilities, clothing, food and personal care items.

The Home-Delivered Meals Program provides nutritionally sound meals to frail older adults who find it difficult to prepare meals. The meals are delivered to homebound persons 60 years or older, or adults with disabilities, who are unable to shop or prepare meals for themselves.

The Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) programs provide assistance to people with disabilities. This page provides detailed information to help you understand what to expect from Social Security during the application process.

Women, Infants, and Children (WIC) is a federally funded Special Supplemental Nutrition Program of the Food and Nutrition Service of the United States Department of Agriculture and is administered by the Michigan Department of Health and Human Services, serving low and moderate income pregnant, breastfeeding, and postpartum women, infants, and children up to age five who are found to be at nutritional risk.

Healthcare

Medicaid is a joint federal and state program that provides health coverage to children, pregnant women, parents, seniors, and individuals with disabilities.

Medicare is a federal health insurance program for retirees age 65 or older and people with disabilities.

Medicare Rights Center is a national, nonprofit consumer service organization that works to ensure access to affordable health care for older adults and people with disabilities through counseling and advocacy, educational programs and public policy initiatives.

MI Bridges is a website designed to help you apply for benefits, explore resources, and manage your case.

Michigan Department of Health and Human Services - Health Care Coverage for Persons with Disabilities provides information regarding Long-Term Care and Medicare savings programs.

National Health Law Program includes detailed information about federal health policy, especially Medicaid and Medicare.

Legal Advocacy

Legal Aid and Defender Association is a nonprofit organization that aims to provide holistic, innovative legal services to improve the quality of life and empower vulnerable and underserved individuals in Wayne, Oakland and Macomb counties who cannot afford an attorney.

Legal Aid of Western Michigan is a nonprofit law firm providing free legal advice and representation in a broad range of areas including consumer cases, family matters, housing problems, government benefits, and much more.

Legal Services of Northern Michigan provides a full range of legal services in areas of civil law, including renters and consumers rights, assistance programs, family law, and financial law for people who meet Federal poverty guidelines or who are 60 years of age or older.

Legal Services of South Central Michigan (LSSCM) provides free legal advice and representation to low-income individuals, families, and older adults in Barry, Branch, Calhoun, Clinton, Eaton, Hillsdale, Ingham,

Jackson, Lenawee, Livingston, Monroe, Shiawassee, and Washtenaw Counties.

Michigan Advocacy Program provides access to the justice system for a variety of populations.

Michigan Indian Legal Services provides legal services statewide to income-eligible individuals and Tribes, advocates for the rights of individuals, which advances systems of justice, and works to preserve Indian families through state and tribal courts.

Michigan Legal Help is for people who are handling their legal problems without a lawyer, but can help individuals find a lawyer, and better understand legal forms and procedures on a variety of topics.

Self Advocates Becoming Empowered (SABE) is the United States' national self-advocacy organization that works to ensure that people with disabilities are treated as equals and are given the same decision-making opportunities.

Treatment and Rehabilitation

Ascension Macomb-Oakland Hospital Neurological Recovery Systems is committed to helping survivors of brain injury in rebuilding their physical, cognitive, and social skills and abilities, which may have been lost or impaired by their injury.

Aspire Rehabilitation specializes in treating survivors of traumatic brain injury and spinal cord injuries. Services include semi-independent apartments, staff training, individual and family therapy, comprehensive behavioral interventions, and more.

BrainTrainers is a holistic therapeutic day program for brain injury neuropsychological rehabilitation located in Ann Arbor, MI.

Semesters start twice a year in January and July.

Communicare Michigan specializes in postacute rehabilitation of traumatic brain injury with 3 different therapeutic components, including a comprehensive set of Outpatient Therapies, Day Programs and a Semi-Independent Living Program. Communicare aims to provide customized rehabilitation opportunities in the least restrictive environment for each individual.

Community Connections provides supported independent living services to individuals with brain injuries who have successfully progressed through clinical rehabilitation programs.

Deer Run Rehabilitation has an inpatient facility specifically designed for clients with traumatic brain injuries and spinal cord injuries as well as a semi-independent living program.

Diamond Home Care provides comforting care in the home – so you or a loved one can recuperate, deal with a medical condition, or age safely and securely at home. Specialty services for catastrophic injuries such as traumatic brain injury, spinal cord injury and more.

Galaxy Brain and Therapy Center is both Clinic and Home Community based. Treatment focuses on exercising the whole brain while simultaneously exercising the body. This is done through combining neuroscience and functional outcomes to individualize therapy and vocational programming.

Hope Network Neuro Rehabilitation provides post-hospital rehabilitation services and specialized medical care for those who have sustained a brain or spinal cord injury, or other neurological condition.

Independent Life Supportive Services offers semi-independent residential rehabilitation for traumatic brain injury.

Mary Free Bed Rehabilitation Hospital provides comprehensive services to individuals with a variety of conditions, including programs for traumatic brain injury programs for adults and children.

Michigan Rehabilitation Services (MRS) is a statewide network of vocational rehabilitation (VR) professionals developing creative, customized solutions that meet the needs of individuals and businesses. MRS delivers individualized services that assist potential employees with differing abilities prepare for, pursue, and retain careers.

Rehabilitation Institute of Michigan (RIM) is a member of the Detroit Medical Center (DMC), and is one of the nation's largest providers of physical medicine and rehabilitation services.

The Habilitation Supports Waiver Program (HSW) is an intensive home and community based, active treatment and support program, designed to assist individuals with severe developmental disabilities to live independently with supports in their community of choice

The Michigan Medicine Traumatic Brain Injury Program is a comprehensive program of cognitive, psychosocial and physical rehabilitation. The Traumatic Brain Injury Program provides intensive services to promote increased independence with inpatient and outpatient settings.
